# How to register for Summer Camp

## REGISTERING IS AS SIMPLE AS 1, 2, 3!

1. **Fill out the registration form completely.** Be sure to print or type and list first and second choices.
2. **Attach payment or deposit.** \$50 deposit is required for each camp session. \$15 deposit is required if applying for financial assistance as well as a copy of your Campership Financial Assistance Application and recent IRS tax return. (Remaining balance of camp fee is due four weeks prior to the first day of session.)
3. **Send in your registration**

### For Camp Todd Summer Roundup:

To pay by check, mail application form and deposit check payable to "Summer Roundup" to Amy Schisler at PO Box 355 Bozman, MD 21612. To pay by charge, please send to GSCBC using the address on the registration form. The balance of the fee is due by June 1, 2010.

Once notified of placement in a session, it is expected that fees will be paid unless exceptions are made in the format stated in the Refunds and Cancellations section in General Information. No child is allowed to attend camp until full payment of fees has been received.

Upon receipt of your camper's registration form and deposit, you will be sent a confirmation packet that will include some or all of the following information (dependent on the camp).

- Parent or guardian letter
- Session and program placement
- Transportation schedule
- Health form
- Packing list
- Directions

Forms to be returned must be received at least one week prior to the start of the first session.
